The Ministry of Manpower, through the Directorate General of Industrial Relations Development and Social Security, continues to finalize the scheme to protect the pension insurance program for workers. This is a form of social security program, which aims to protect the livelihood and welfare of workers when they enter non-productive age.

The Minister of Manpower, Ida Fauziyah, in his speech at the event entitled "Discussion of Reform and Harmonization of the Pension Security Program", which was held in Jakarta, last Wednesday (20/7/2022), said, in the context of protecting social security for people in old age, this is related to with the old-age insurance and pension guarantee programs, the government currently still needs to carry out harmonization. The aim is to provide protection as a follow-up to the principle of mutual cooperation in the national social

security system as mandated in Law Number 40 of 2004 concerning the Social Security System (UU SJSN).

Referring to BPJS Employment data, Ida noted that there were 13.65 million participants in the pension insurance program out of a total working population of 135.61 million (BPS data February 2022). "The findings show that only around 10 percent of workers have a pension program. This needs to be our collective attention and focus so that we can find a solution, in order to provide protection and guarantee welfare for the community while still paying attention to the country's fiscal capacity," said Ida.
